## World Tour 2025 FAQ

### WHAT IS THE PM WORLD TOUR?

PM-World Tour means: Every year a different dream destination, every year an incomparable dream vacation exclusively with Rolf and Vicki Sorg! Let this dream trip of superlatives become an unforgettable experience for you!

### WHAT ARE THE QUALIFICATION REQUIREMENTS?

This is how you can participate:

- You are a member of the PM Top Management (VP or higher) by no later than November 2024.
- Within 12 months you qualify at least 2 new qualification lines to fully qualified (confirmed) IMM until November 2024. The 12-month period begins with the registration of the first IMM once a full month has passed.
- You personally confirm your level of VP continuously in the last 3 months before the travel incentive!

The qualifying date for the World Tour 2025 is 30.11.2024!

If the qualification is confirmed after November 2024, but within the 12-month period, then you can participate in the World Tour 2026.

### THIS IS HOW YOU QUALIFY FOR THE WORLD TOUR 2025?

You are at least Vice President and qualify at least 2 new levels to IMM within 12 months. These must confirm the position within the 12-month qualification period by 30.11.2024 at the latest.

All further fully qualified IMM by the cut-off date 30.11.2024 cannot be transferred to the next qualification period. Cancellation can take place until the deadline (this only applies to qualifiers of the current Incentive).

<b>1<sup>st</sup> new partner</b> First full month in May 2023 IMM confirmed in April 2024	Since 13 months lie between the first full month of the 1st IMM and the qualification date of the 2nd IMM, then the qualification for the World Tour 2025 has unfortunately not been achieved.
<b>2<sup>nd</sup> new partner</b> First full month in August 2023 IMM confirmed in May 2024	
<b>1<sup>st</sup> new partner</b> First full month in February 2024 IMM confirmed in August 2024	Because max. 12 months lie between the first full month of the 1st IMM and the qualification date of the 2nd IMM and the qualification has taken place after the 30.11.2024 then you have qualified for the World Tour 2026.
<b>2<sup>nd</sup> new partner</b> First full month in February 2024 IMM confirmed in January 2025	

**WHEN IS THE WORLD TOUR 2025 TAKING PLACE?**

March 15th to 22<sup>nd</sup> 2025

**CAN I ARRIVE EARLY OR EXTEND MY STAY?**

The Incentive has an official start and end date, which is binding to the distributor's participation. Different flight or travel times are not foreseen and not desirable!

Exception: If the flight time (real flight time not the break between two flights) is more than 12 hours, it's possible to arrive the day before.

**WHERE IS THE WORLD TOUR 2025 TAKING PLACE?**

To Phuket - Thailand.

**I WANT TO TAKE MY PARTNER WITH ME. WHAT OPTIONS DO I HAVE?**

The surcharge of the Love Package is 1.650€\*. Due to organizational reasons the participation of children is not possible. The Lovepackage is only limited for spouses/ life partners. This is only possible if there is adequate room capacity.

**ROOMS:**

The hotel arrangement is based on qualification and turnover in the month of January 2025. Only the Team Partner number which achieved the World Tour qualification requirements counts. The room division is always in double rooms.

**SEATING RESERVATION:**

In case there is a seating reservation at the final evening, this is based on qualification and turnover in the month of January 2025. Only the Team Partner number which achieved the World Tour qualification requirements counts.

**ENTERING THE COUNTRY:**

The passport must be valid for at least for the duration of the stay (this may vary from country to country, please check the regulation for your country). If necessary, relevant visa regulations must be observed by the travelers themselves.

**HOW MUCH DOES A SINGLE ROOM COST?**

The cost surcharge for a single room is 1.500,-€\*. Single rooms are limited in availability and cannot be guaranteed. The allocation takes place after the applications have been received.

**INVOICING:**

All payments will be withdrawn in the month before the beginning of the Incentive by the payment method registered with us (e.g. surcharge for single occupancy, Love Package, etc.)

**ADDITIONAL FEES CAN BE INCURRED:**

A service fee of 50€ for each alteration will be charged for any subsequent changes after the registration deadline. (E.g. changes of your accompanying person)

**WHEN CAN I MAKE ANY CHANGES BY?**

For organizational reasons, changes, such as a different accompanying person etc., can only be considered up to 30 days before the start of the trip.

**CAN I WITHDRAW FROM THE INCENTIVE?**

The Incentive can only be redeemed by the qualifier. If two people are registered under the same TP-ID (e.g. spouse, family, etc.) then the Incentive only applies to one of these two people. The second person can participate for the price of the Love Package. The Incentive can only be redeemed for the specified period.

**CANCELLATION POLICY:**

Registration is binding from the 31st of December 2024 and from then on 100%\* cancellation fees apply. The cancellation fees include all costs incurred outside of the Incentive (e.g. Love Package\*, single rooms\*, etc.)

We recommend private travel insurance so that any costs are covered.
